

SMARTPAY POS TERMINAL TERMS AND CONDITIONS FOR POS OPERATORS

1. Introduction

These Terms and Conditions ("Terms") govern the collection, use, and maintenance of SmartPay POS terminals ("POS Terminals") by POS operators ("Operators"). By collecting and using the POS Terminals, Operators agree to comply with these Terms.

2. Eligibility

Operators must be duly authorized businesses or individuals with the legal capacity to enter into binding agreements.

3. Collection of POS Terminals

3.1. Operators must provide valid identification and business documentation when collecting POS Terminals.

3.2. Operators are responsible for inspecting the POS Terminal at the time of collection and reporting any defects or issues immediately.

4. Use of POS Terminals

4.1. POS Terminals must be used exclusively for processing payments through SmartPay.

4.2. Operators shall not modify, tamper with, or attempt to repair the POS Terminals without prior written consent from SmartPay.

4.3. Operators are responsible for ensuring that the POS Terminals are used in compliance with all applicable laws and regulations.

5. Maintenance and Care

5.1. Operators are responsible for the proper care and maintenance of the POS Terminals.

5.2. Operators must promptly report any malfunctions or damages to SmartPay.
